R U L E B O O K

ON AMENDMENTS

TO THE RULEBOOK ON THE RULES FOR ESTABLISHMENT AND BUSINESS OPERATIONS OF BRANCHES OF INSURANCE COMPANIES IN INTER-ENTITY BUSINESS OPERATIONS

Article 1

In the Rulebook on the rules for establishment and business operations of branches of insurance companies in inter-entity business operations (Official Gazette of the Republic of Srpska, 77/19 and 96/19), Article 12, paragraph 6, is amended to read

"(6) The company from the FBiH shall submit to the RS Agency any amendment to the acts referred to in paragraph 4 of this Article, including the obligation to submit the newly adopted insurance conditions and tariffs and their amendments in order to verify the compliance of those acts with the laws of the Republic of Srpska, rules profession and actuarial principles."

In the same article, after paragraph 6, a new paragraph 7 is added, which reads:

"(7) The acts referred to in paragraph 6 of this Article shall be submitted within 15 days from the day of adoption, signed, certified, scanned and in electronic form."

Article 2

In Article 20, in paragraph 1, after point 2), a new point 3) is added, which reads

"3) Report on the premium of compulsory auto liability insurance of the RS (Form PM-AO-F),"

In the same article, and in the same paragraph of the previous points 3), 4), 5), 6), 7), 8), 9), 10) and 11) become points 4), 5 6), 7), 8), 9), 10), 11) and 12).

In the same article and in the same paragraph, in point 11) at the end of the text, the word: "and" is replaced by a comma, and in point 12) at the end of the text, the point is replaced by a comma and new points are added. 13) and 14) which read:

"13) Report on the use of the services of agents/brokers in insurance (Form ZPO-F) and -

14) Report on the costs of insurance implementation and allocation of acquisition costs by types of costs (Form TSO1-F).

In the same Article, in paragraph 2 in point 1) after the text: "from paragraph 1 point 1." the word: "and" is replaced by a comma, and after the number: "2" the word and number is added: "and 3.".

In the same Article, and in the same paragraph, in point 2), the words: "from 3 to 11" are replaced by the words: "from 4 to 13".

In the same Article and in the same paragraph, after point 2), a new point 3) is added, which reads: "3) from paragraph 1, point 14 of this Article quarterly for the periods:

1. from 1 January to 31 March, within one month of the end of the reporting period,

- 2. from 1 January to 30 June, within one month from the end of the reporting period,
- 3. from 1 January to 30 September, within one month of the end of the reporting period,
- 4. from 1 January to 31 December, within two months from the end of the reporting period."

The forms from this Article are an integral part of this Rulebook.

Article 3

This Rulebook shall enter into force on the eighth day from the date of publication in the Official Gazette of the Republic of Srpska.

In columns 5 and 8 of this form, Total costs of implementing insurance (TSO), enter the total amount of realized and posted costs of the branch in RS for the period 01.01. by the end of the reporting period, by types of expenses, separately for non-life and life insurance. 2. In columns 6 and 9 of this form Deferred costs of purchase (RTP) enter the change in accrued direct acquisition costs for the period 01.01. until the end of the reporting period. The change in RTP represents the amount obtained as the difference between the RTP balance at the beginning of the reporting period and the RTP balance at the end of the reporting period. The balance is obtained by calculating the RTP at the end of the reporting period. If the RTP balance increases, the amount with a minus sign is entered (posting: reverse from the expense account to the RTP change account) and vice versa.

3. After deferral, the TSO must correspond to the balance on the analytical accounting card of the branch in RS.
